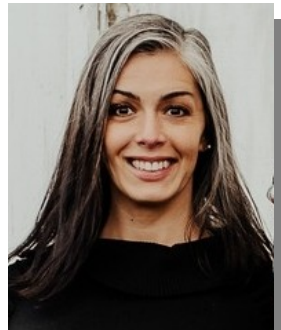

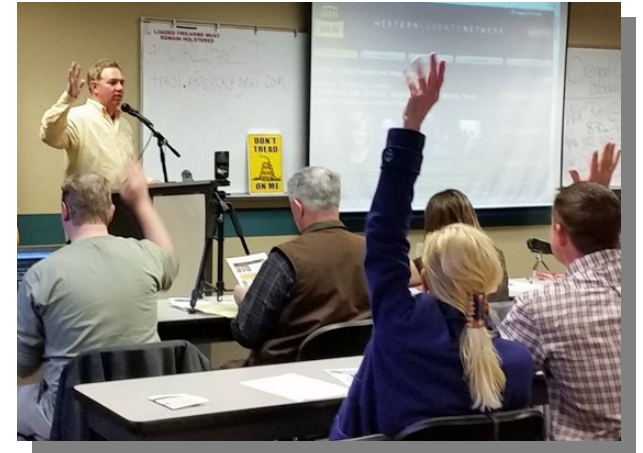

### ② Building a Generation or “Farm Team” of Limited-Government Office Holders

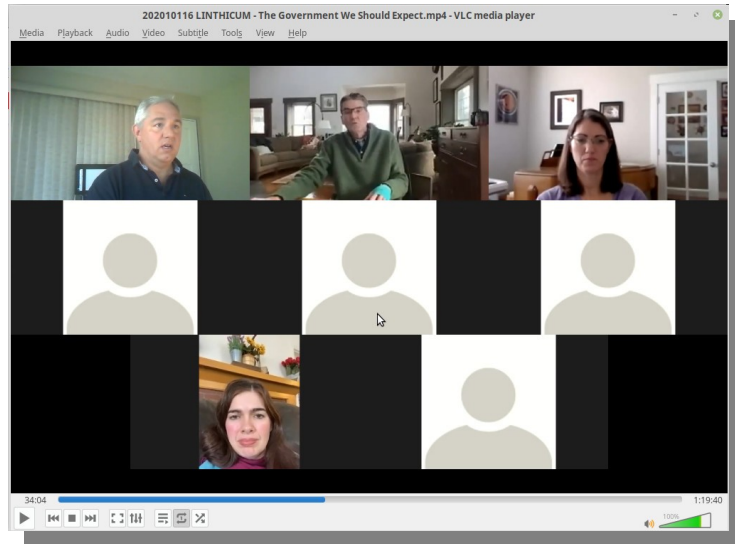

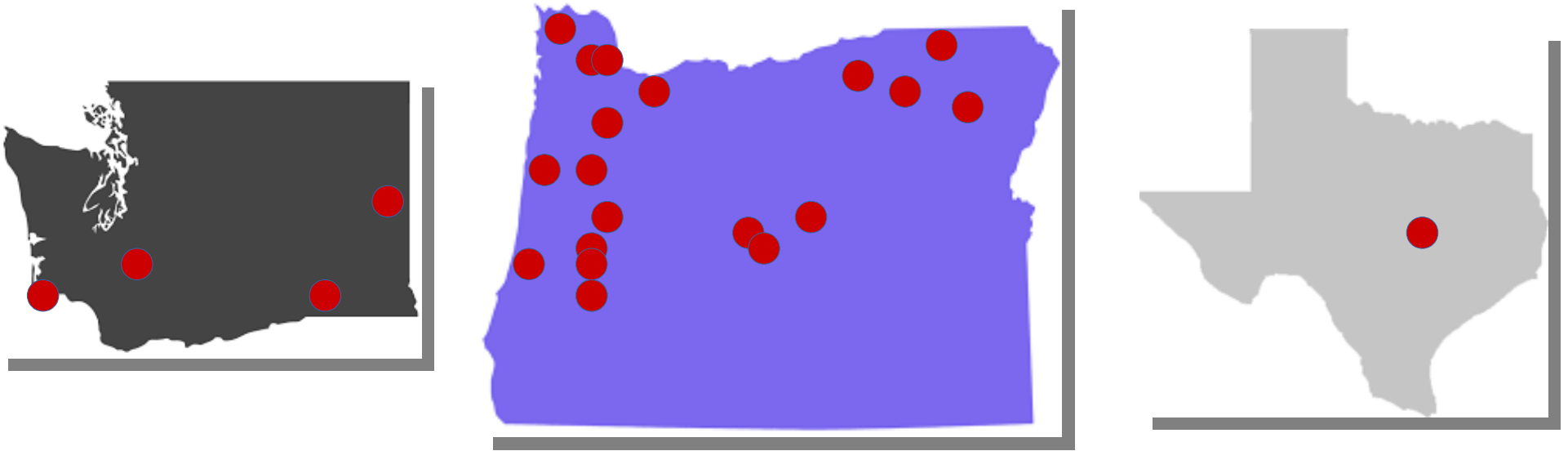
## ③ Building on WLN's Online and Other Training Resources
